1. Application pursuant to par. 1 of Article 5 of Government Gazette 4899/issue B'/16.09.2022.

2. Solemn Declaration, (of the article 8 of Greek Law 1599/1986) containing the following text:

"I have not made use of the right to be exempted from tuition fees at Postgraduate Programme of Studies. with the provision of article 86 of Law 4957/2022 and I do not receive a scholarship from another source".

3. The required supporting documents, as described in article 5, par. 1, 2, 3 and 4 of Ministerial Decision 108990/Z1/08.09.2022 (Government Gazette 4899/t.B'/16.09.2022)

Note:

1. Applications that do not meet the requirement of the undergraduate degree with a grade of 7,50/10 or higher (or the equivalent in a foreign grading system) will not be accepted as valid applications.
2. Applications that will be sent after the above deadline will not be accepted as valid.
3. All the above supporting documents must be submitted electronically.
4. The original documents in paper must be held by the applicant in case it is required to be sent by mail to us.
