

International Academic Partnership Program (IAPP) – Greece Executive Briefing Paper

December 2019 – September 2023

Program Overview

The International Academic Partnership Program (IAPP) was developed through <u>IIE's Center for International</u> <u>Partnerships</u> in 2009 in response to the demand from higher education institutions to develop comprehensive, sustainable academic partnerships with their counterparts abroad. The IAPP is unique in its multi-faceted approach, combining strategic planning, virtual communication, group learning, and face-toface interactions to help institutions find the right partners. The IAPP typically focuses on connecting U.S. higher education institutions with partners in a target country. To date, IIE has led more than 20 IAPPs with 13 different countries, which have resulted in new and enhanced academic partnerships between U.S. colleges and universities and institutions around the world.

In 2019, IIE launched IAPP Greece in collaboration with the Greek Ministry of Education and Religious Affairs. The primary objective of IAPP Greece is to increase and support the number of sustainable U.S. – Greek academic partnerships, including student mobility, joint research, faculty exchange, and more. To achieve this goal, the program has thus far focused on: enhancing knowledge of U.S. and Greek higher education systems; providing tools and resources for developing a partnership strategy; and creating opportunities, both virtual and in-person, to convene both sides and strengthen ties between potential partners.

Initiated in December 2019, participants were selected via an application process, promoted throughout IIE's social platforms, newsletters, and individual outreach. The program adapted rapidly to the COVID-19 pandemic, adding virtual meeting components when travel was not possible. During this time, 92% of participating institutions were able to reach out to potential counterparts to start partnership conversations. In November 2022, delegates from universities and governments of both countries convened in Greece for the Pharos Summit (detailed below). The Greece program became IIE's largest IAPP to date, attracting nearly 70 representatives from U.S. universities. This weeklong event included site visits to all 24 public Greek universities, the Presidential Mansion in Athens, and the U.S. Embassy in Greece. IIE has created a survey to track the ongoing partnership activities initiated through the Summit.

Key Partners

The IAPP Greece program and Pharos Summit would not have been possible without our own administrative partnership with organizations and government entities in both countries. These are:

Ministry of Education, Religious Affairs, and Sports of the Hellenic Republic

The Ministry of Education, Religious Affairs and Sports of the Hellenic Republic is a government department of Greece, and one of the country's oldest ministries. Established in 1883, its mission is to ensure that children and young people in every part of the country get a good education and are prepared with the knowledge, skills and qualifications they need. The Ministry works to level up education standards and create a smart, creative and innovative environment. Internationalization of Greek higher education lies at the heart of the Ministry's vision. Committed to enhancing the quality of instruction and research, and fostering collaboration between Greek and international higher education institutions, the Ministry has developed a strategic plan centered on a clear, long-term vision focusing on openness, outreach and international synergies in the fields of academia and research. The IAPP Greece program highlights the Ministry's efforts to boost academic cooperation and educational exchange between Greece and the U.S., a country with which Greece has a deep and strong bilateral relationship and shares common cultural values.

Institute of International Education (IIE)

IIE is a global non-for-profit organization that helps people and organizations leverage the power of international education by implementing international education programs, conducting research, and providing life-changing opportunities for students, scholars, and artists worldwide. The IAPP Greece program rests in <u>IIE's Center for International Partnerships</u>, which seeks to provide higher education institutions the tools and resources to develop sustainable academic partnerships. In this capacity, IIE is primarily the convener of the U.S. institutions involved in IAPP, and is also central to the planning and implementation of IAPP programmatic activities.

Fulbright Greece

Fulbright is the flagship international educational and cultural exchange program of the United States of America in partnership with more than 160 countries worldwide. It offers competitive scholarships to students, scholars, artists, teachers and professionals of all backgrounds to study, teach and conduct research helping to build mutual understanding and find solutions to critical international concerns.

The United States Educational Foundation in Greece also known as Fulbright Greece was established in 1948 as a non-profit, non-political educational organization through a binational treaty between the United States and Greece. The Foundation fosters academic and cultural exchanges between Greece and the United States through the Fulbright Scholarship Program for Greek and U.S. citizens and the Advising Center for studies in the United States while it also provides information about study opportunities in Greece. Since 1948, the Foundation has offered free educational advising services to thousands of individuals and has awarded more than 6,000 scholarships facilitating student and scholar mobility between the two countries. Grant opportunities are offered in all fields and disciplines to students, scholars, teachers, professionals, scientists, and artists. Recruitment for all educational exchange programs is based on open and fair national competition as well as individual merit and academic excellence.

Study in Greece

SiG is Greece's official body for the internationalization of higher education, international promotion of Greek universities, and international students services. Consisting of representatives from all Greek universities, and backed by the Greek state, SiG's vision is to make Greece a top study abroad destination. The SiG portal is a comprehensive, official resource on Greek higher education, and SiG's digital platforms facilitate networking between Greek and international institutions, scholars and researchers, and provide useful information and guidance to prospective international students. SiG represents Greek universities at

international education fairs, organizes information sessions and promotional campaigns, and guides Greek HEIs in developing strategic international partnerships. SiG is excited to be part of the IAPP Greece program aimed at promoting enhanced collaboration between U.S. and Greek universities.

U.S. Embassy in Greece

The U.S. Mission to Greece operates through the U.S. Embassy in Athens and the U.S. Consulate General in Thessaloniki, together with numerous U.S. agencies in support of a robust bilateral agenda. To further strengthen U.S.-Greek relations, the United States and Greece launched a Strategic Dialogue in 2018 that focuses on regional cooperation, defense and security, trade and investment, energy, law enforcement and counterterrorism, and people-to-people ties. Fostering educational ties between the United States and Greece is a key priority for the Mission, as education plays a significant role in advancing our economic and people-to-people ties. The Embassy and Consulate support international student mobility and educational partnerships through grants, exchange programs, the media, and more.


IAPP Greece Advisory Board

Pharos Summit (November 2022 trip to Greece)

In November 2022, 64 representatives from 30 U.S. universities traveled to Greece to meet with counterparts at the Greek universities and discuss potential collaboration opportunities. The week began with an Introductory Partnership Workshop and Opening Ceremony at the Stavros Niarchos Foundation Cultural Center, with remarks from Prime Minister Kyriakos Mitsotakis, Minister Kerameus, Assistant Secretary Satterfield, Ambassador Tsunis, and IIE CEO Allan Goodman. The delegation then divided into smaller groups to visit each of the universities in Athens. In the following days, the U.S. delegates selected one of four multi-day routes outside of Athens: Crete, Thessaloniki and Thrace, Peloponnese and the Aegean, and Northwest Greece. The group then reconvened in Athens for a closing reception hosted at the Presidential Mansion. A copy of the agenda can be found in the appendix.

Takeaways and Initial Evaluation from Summit

In a post-Summit survey, IIE found that:

- **90% of the participating American universities and colleges are actively moving forward** in advancing partnership with their Greek counterparts, including summer schools, joint research, student and faculty exchanges, and joint diplomas.
- When asked for one word to describe participants' time with the Pharos Summit, top responses were: **Engaging, Productive, Inspiring, Informative**
- Participants found that **speaking directly with individuals in government and at the universities** were the most effective aspects of the Summit. If anything, participants would have benefited from even more time at the site visits, and will be following up virtually to continue conversations.
- 100% of participants responded YES that, as a result of the Summit, they now have a **better understanding of how institutions in the U.S. and Greece can work together.**
- **Nearly all participants identified new partnership opportunities** for their institution as a result of the Summit, as well as deepened existing discussions with counterparts.
- Post-Summit, **participants would still like to learn more** about the various partnership modalities that could be utilized, funding/resources, any updates about new courses or degree programs in English, how others are moving forward with their partnerships, and whether there might be a possibility for a Greek delegation to visit the U.S.

Challenges

Launching successful partnerships is always filled with a variety of challenges, including maintaining momentum and regular communications, garnering buy in from across the institution, developing a shared understanding of what the partnership will achieve, and identifying resources to jumpstart and sustain the partnership. A few U.S. - Greek partnership challenges that were learned throughout the initiative include:

Funding

Funding is the greatest challenge all U.S. survey respondents mentioned. This ranges from concerns around the cost of tuition to the administrative costs needed to manage a successful partnership. In addition to hoping there will be new sources of funding (including seed grants), participants are also interested in learning about creative models for funding new and existing partnerships to maintain the momentum. Funding is especially relevant for student mobility partnerships given the discrepancy in tuition costs between most U.S. institutions and Greek universities. Participants on both sides are encouraged to seek external funding from government, foundation, and other institutional sources.

Institutional Capacity

Several of the smaller regional U.S. universities have mentioned that partnerships surrounding summer schools are not feasible for them as their students typically will need to find a source of income in the summer, instead of traveling abroad. In contrast, partnerships that take place during the academic year would allow those students to apply their tuition (and potentially scholarships as well) toward their semester abroad. Many of these regional universities are also unequipped to enter faculty research partnerships, and perhaps need more guidance on forming partnerships than the larger universities who are more established in the international education space.

Language

As Greek language instruction is not widely administered in U.S. universities, any partnerships on student mobility must be structured in English. Fortunately, many public Greek universities are starting to add more undergraduate courses in English. It is very encouraging to see this increase in instruction in English as that continues to create more opportunities for future partnerships.

Looking Ahead

IIE and Study in Greece will be hosting a series of virtual discussions for the representatives from both countries on topics that will help advance their partnerships. IIE will continue to survey participants on ongoing progress and will continue to offer consultation services to any of the participants who may be experiencing challenges in their partnership development.

There is great interest and momentum in Greece to hold a Pharos II. We have also considered the idea of implementing a delegation of Greek university representatives to the U.S. for a study tour. Planning for this has not yet begun, but we hope to accomplish it in the next several years.
